It's with great pleasure, that I share my story with « SANUVOX » on the C2000X unit I had installed in our home last spring.


For the last few month, I have suffered from allergies such as : dust, pollen, perfum, and cats. A nightmare for me, I have lots of cats at home, my daily routine became very difficult.

I would sneeze often, had difficulty to breathe, specially in the morning. I refuse to use traditional medicine to help my allergies such as asthma pump. I had to take a Benadryl pill every day to help me.

Since the installation of the Sanuvox Unit, my allergy symptoms have been reduced significantly. I take a Benadryl pill only twice a week, and I sometime go a full 10 days before I take a pill.

An interesting note to share as well. This summer, my allergy symptoms came back as if there were no Sanuvox unit install in the house. After verification, my husband found out that the filter was completely blocked not letting any air through, We changed the filter. Now that the air pass through the Sanuvox, again I feel much better.

Subject: Sanuvox


Generally I am not one to write letters about a specific product, but in this case the Sanuvox has surpassed my expectations. The Sanuvox was installed in our home and within hours, I found that I could breathe better and the air in our home had a fresher smell. Since the Sanuvox works only while the air or the furnace is operating, we left the fan on the heating and cooling unit continually. 

Subject: Smoking Room Unit 402 Second Hand Smoke Cleanser System

Gentleman,

Since the installation of your Model S1000 Second Hand Smoke Cleanser System, we are completely satisfied with its efficiency in controlling the smoke and odors due to the smokers in the smoking room.

The Sanuvox S1000 was installed due to the fact that patients and Health Sector staff complained about the secondhand smoke and persistent odors penetrating the corridors and adjacent rooms of the smoking area.

We have used your Second Hand Smoke Cleanser System since October 1998 and appreciate the fact that it has operated extremely efficiently and quietly. It is used in a smoking room, which is approximately 250 square feet. In this area, there are on average 8 smokers at any one time, and a maximum of 15 smokers. Since installing the Sanuvox S1000, the smoke and odors are cleaned up very quickly. The maintenance is easy and requires a minimum of labor, considering the environment where it must perform.

When our institution agrees on the application of the new Tobacco Act, we will study the possibility to install other units in other areas that have similar problems in our institution.

Subject: Mold & Mildew in B Wing

To Whom It May Concern:

In November of 2001 we experienced a compressor failure in the 30 ton A/C unit cooling one wing of the hospital. At this time the building was empty, so we decided to postpone replacing the compressor. This was a big mistake! Being in Florida and the high humidity, it only took a couple of weeks for the mold and mildew to take over. It was all over the walls, the ceiling, and the space above the dropped ceiling.

We hired a professional cleaning service to eliminate the problem. This cleaning was very expensive and took several days to complete. We also, at this time, had the compressor in the A/C unit replaced, hoping we had cured the problem. But, to our surprise, we noticed the mold had returned. We then had the same company return to clean the wing again. The cost was the same as before and time consuming.

A couple of weeks later we noticed the mold had returned for the third time. This time I suggested that we call Fred Huffman with Clean Air Innovations to take a look at the situation. He recommended installing a Sanuvox bio-wall ultra violet system in the A/C system cooling that wing of the hospital. Since the cost of installing the Sanuvox was a fraction of the cost of the cleaning jobs, we decided to give it a try.

Before Fred installed Sanuvox bio-wall, breathing was very difficult in this wing, due to mold spores in the air. We had to wear masks when in this area. In just 3 days after the Sanuvox was installed the wing smelled fresh as the outdoors. The mold and mildew disappeared in just a few days, and has not returned. That was over 6 months ago.

To our surprise, 2 weeks later we got a bonus. We started to find a large amount of bugs and insects dying all over the wing. To our surprise it was due to the Sanuvox system. They were feeding on the mold and mildew. When their food source died so did the bugs.

I highly recommend the Sanuvox system and Fred Huffman at Clean Air Innovations. The system works! Thanks for solving a very serious problem.

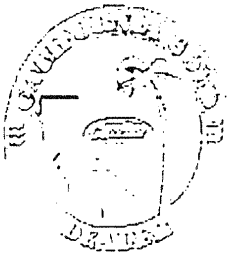


